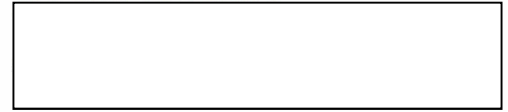


2018 National Senior Teams Championships

Attention: All Senior Bowlers



Strike Entertainment Centre, Lower Hutt are interested in entering teams into this year's National Senior Teams Championships, to be held at North City Tenpin, Porirua, September 7th-9th

We are now calling for expressions of interest from players who would like to trial for these teams.

Trials will be conducted, and players are required to complete a minimum of 3 trials to be eligible.

The top 4 male, and top 4 female trialing, will be selected based on total pinfall from their trials.

Trials will be held on the following dates :

- Monday 14nd May, 2018, 6:00pm
- Wednesday 16th May, 2018, 5.00pm
- Saturday 19th May, 2018, 9.00am
- Sunday 20th May, 2018, 5.00pm
- Tuesday 22th May, 2018, 6:00pm
- Wednesday 23th May, 2018,, 6:00pm
- Sunday 27th May, 2018, 5.00pm
- Tuesday 29th May, 2018, 6.00pm
- Wednesday 30th May, 2018, 6.30pm

Cost per trial will be \$30 per person, and shall consist of 6 games at each trial.

You must notify Kerry or Steven for which night(s) you wish to trial. If there is no interest in a trial 24 hours prior, that Trial will be cancelled. If you turn up without notifying us then the lanes will be in the state they are in.



Please note, there will be individual costs to compete in this tournament. While Strike endeavours to help as much as possible, we cannot bear the costs involved. An estimated cost will be distributed during trials so bowlers will have an idea of their costs before commencement.

Each person:

- Must be over the age of 50 or turning the age of 50 during the 2017 calendar year.
- Must be capable of conducting themselves in a manner so as not to reflect discredit on the sport of Tenpin Bowling or the Centre they are representing.
- Must have qualified for the Centre team in accordance with the criteria set by the Committee.
- Trialists are only permitted to compete in trials for ONE centre/team.
- Bowlers must have bowled a minimum of 24 games in a recognised league in the Centre they wish to represent during the current year.
- For the purposes of qualification for a Centre team in accordance with rule 4.4, a league must consist of a minimum of six separate bowling sessions with a minimum period of seven days between the commencement of one bowling session and the commencement of the immediately subsequent bowling session.
- League sessions that are pre-bowled or post-bowled will NOT count towards the 24 games required.
- A bowler wishing to represent a Centre where they do not meet the criteria in 4.4 may apply in writing to the tournament organising committee for an exemption, prior to the commencement of the team trials.
- All bowlers must attend Team training on each specified night. Allowances will be given for those that cannot attend for special circumstances. There will be a penalty for non attendance that will be discussed with the team for not attending without prior permission.
